Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Recorder Lisa Schreiner reported that her office has been busy with boat registrations. They are due before the end of April. County Treasurer Brenda Buck stated that the deadline for paying property taxes without penalty was April 1<sup>st</sup>. Emergency Management Director Gina Hardin reported that Spring/Summer information has been posted on the County's website. The Day of the Child will be held at Westland Mall on Sunday, April 7<sup>th</sup>. Training for Emergency Responders will be held April 8<sup>th</sup>.
