June 21, 2016

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, June 21st, 2016, with Tom Broeker, Bob Beck and Jim Cary present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: the County Auditor announced that ballots for the West Burlington City Council Special Election are available for early voting. That election will be held on July 5th, 2016. Maintenance Supervisor Rodney Bliesener reported that the ramp at the Health Department is done except for the handrail. It will be installed in the next few days. County Engineer Brian Carter reported that the contractor is milling on Hwy 99. Crews are ditching, hauling rock and replacing culverts. Rain is needed for blading to be effective but eventually crews will have to start that project. Director Chris Lee reported that Conservation is getting ready for the July 4th weekend. He asked the Board to take a project tour on Friday, July 1st to see their preparations. He expects the shower house at Big Hollow to be built next spring. Christa Poggemiller, Administrator of Local Health, reported that the last of four material exercises were finished last Tuesday. County Attorney Amy Beavers reported that the office is preparing for two big trials coming in August and September. Administrator Doug Ervine reported that the jail was getting ready for the annual state inspection on Friday. County Treasurer Janelle Nalley-Londquist reported that there were 115 registered bidders at the tax sale yesterday. The County took in \$325,000 in delinquent taxes.

County Engineer Brian Carter presented a Federal Aid agreement for the Pleasant Grove Road (H40) bridge deck. Beck moved to approve. Seconded by Cary.

Cary moved to open a public hearing for the vacation of a portion of Ferry Street in the village of Augusta. Seconded by Beck. Carter explained that the owner of the entire block of property asked to vacate and take title to this part of the street. There was no public comment. Motion to close the public hearing was made by Beck and seconded by Cary.

A Resolution to vacate a portion of Ferry Street in the unincorporated town of Augusta was read by Broeker. Motion to approve the vacation was made by Beck and seconded by Cary.

RESOLUTION WITH REFERENCE TO ACTION OF VACATING ROAD

BE IT RESOLVED:

That in accordance with the provisions of Chapter 306 of the 2015 Code of Iowa, as amended, the Board of Supervisors of Des Moines County, Iowa, meeting this 21st day of June, 2016, take action in the matter of vacating and closing a certain Des Moines County road on which hearing was held June 21st, 2016 as follows:

That the following described road be vacated and closed and the easement relinquished:

Commencing at the intersection of Ferry Street & Skunk River Road in the town of Augusta, Des Moines County, Iowa, in sections 23-69-3 & 24-69-3, thence northerly approximately 40 feet to the north right of way line of Skunk River Road and point of beginning; thence 357.1 feet northerly along the centerline of Ferry Street, meeting up with the May 16, 1978 Vacation of Ferry Street.
