August 23rd, 2016

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, August 23rd, 2016, with Tom Broeker, Bob Beck and Jim Cary present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Deputy Auditor Terri Johnson repeated the requirements for yard signs. Signs cannot be placed in the road right-of-way. They must be placed behind the sidewalk. If there is no sidewalk, then use utility poles as a reference. Entities can remove any signs placed in their right-of-way. County Engineer Brian Carter reported Madison Ave is now closed and removing pavement. Hwy 99 work is continuing, adding the granular shoulders and completing dirt work. The Gear Ave project is moving along. The road crews are pinching in several roads and will be replacing a bridge deck west of Mediapolis. Conservation Director Chris Lee is finishing the annual report for the volunteer banquet on August 27th at the Capitol Theater. Emergency Management Director Gina Hardin is working on issues that came up during the Maryland training. Deputy Recorder Natalie Steffener stated the Off Road Vehicle and Snowmobile renewal period begins September 1st. County Treasurer Janelle Nalley-Londquist reported they are collecting property taxes. CDS Director Ken Hyndman reported a couple of case managers have resigned and they have advertised for replacements.

Correspondence: Received a letter from ITC Midwest. They are proposing to re-build nine miles of an existing 69 kilovolt transmission line in southeast Iowa from the Burlington Substation to the New London Tap. They have retained Burns & McDonnell to assist in developing potential route alternatives for the Project. The study team would appreciate any comments or information on resources within the study area. Comments should be received by September 21st. Received a letter from the City of Mediapolis. The letter discussed expanding its Mediapolis Housing Urban Renewal Area and amending the urban renewal plan. A meeting to discuss the urban renewal plan amendment is set for August 29th at 10AM at the Mediapolis City Hall. The city council will hold a public hearing on September 19th at 6:45 PM.

Jeff Hanan presented the Resolution and Final Plat for Fischer Subdivision 3. Hanan stated this is a minor one-lot subdivision. Beck moved to approve. Seconded by Cary.

RESOLUTION

WHEREAS Section 354.8 of the Code of Iowa states that a governing body shall certify by resolution the approval of a subdivision plat, and,

WHEREAS the Final Plat for **Fischer Subdivision 3** has been reviewed for conformance to applicable County standards by the Des Moines County Health Department, Secondary Roads Department, County Auditor, Zoning Commission Chair and Land Use Department and has been duly recommended by the aforementioned entities for approval,

NOW THEREFORE, BE IT RESOLVED: That the Board of Supervisors hereby approves the Final Plat of **Fischer Subdivision 3**, with the following condition:

• That Article V Section 6.1 be waived.

Broeker read the resolution requesting approval of amending the Mediapolis Housing Urban Renewal Area. The resolution was requested by the City of Mediapolis. Beck moved to approve. Seconded by Cary.

RESOLUTION

WHEREAS, the City of Mediapolis, Iowa (the "City") is amending the Mediapolis Housing Urban Renewal Area (the "Urban Renewal Area"), pursuant to Chapter 403 of the Code of Iowa to include the real property described in Exhibit A hereto (the "Property);

WHEREAS, project development needs with respect to the Property will require that the city use incremental property tax revenues, as provided for in Section 403.19 of the Code of Iowa, received with respect to the Property to pay the cost of certain public improvements related to the development of a housing subdivision in the Urban Renewal Area (the "Project"); and

WHEREAS, Section 403.22 of the Code of Iowa prohibits cities from collecting incremental property tax revenues for this type of project for more than eleven years without the express consent of any affected county, school district and community college; and

WHEREAS, the City Council of the City has requested that the Board of Supervisors of Des Moines County, Iowa approve this resolution in order to allow the City to use incremental property tax revenues from the Property for five additional fiscal years, as provided by law;

NOW, THEREFORE, it is resolved by the Board of Supervisors of Des Moines County, Iowa, as follows:

Section 1. Pursuant to Section 403.22 of the Code of Iowa, this Board hereby approves the use by the City of Mediapolis, Iowa of future incremental property tax revenues produced with respect to the Property, for a total period of up to sixteen fiscal years.

Section 2. The County Auditor is hereby directed to forward an executed copy of this Resolution to the City Council of the City of Mediapolis.
