October 3, 2017

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9:00 AM on Tuesday, October 3rd, 2017, Bob Beck, Jim Cary and Tom Broeker were present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Auditor Terri Johnson reported the Burlington Primary election is October 10th and the polls are open from 7:00 AM to 8:00 PM. The last day to request an absentee ballot to be mailed is October 6th at 5:00 PM. The Canvass for the City Primary will be held on October 12th at 1:30 PM. County Sheriff Mike Johnstone stated they had a busy weekend. The Jail is full and need to discuss expansion to alleviate the situation. Maintenance Supervisor Rodney Bliesener attended a conference last week and his department is getting ready for winter. County Engineer Brian Carter stated the roads are fine and should get some moisture this week. The low water crossing is progressing and he would like to take the Board to the site. Next week is a Hwy 61 Coalition meeting so he will not be at the meeting. Public Health Administrator Christa Poggemiller stated her department is busy with flu clinics. October 4th is the Healthiest State Walk at Noon starting at the Port of Burlington. On October 28th, from 10:00 AM to 2:00 PM, the Health Department is working with the Drug Enforcement Administration for Take Back Day. This program allows the public to turn in unused or expired prescription medications. They will also accept sharps, bring a full container and receive an empty container.

Correspondence: Beck read a letter received from the Salvation Army regarding their Red Kettle Program. The bells will start ringing on November 6th and conclude on December 23rd. Volunteers are needed to ring the bells.

Cary motioned to approve Accounts Payable Claims in the amount of \$745,385.78. Broeker seconded.

Beck read the Domestic Violence Awareness Month proclamation into the record. Broeker motioned to approve the proclamation. Cary seconded. In attendance was Elias, Heather and Kristal on behalf of the Domestic Violence Intervention Program (DVIP). They stated they are always looking for volunteers. Two events happening in the area are: October 7th is a Flapjack Fundraiser at Applebee's to support outreach. October 18th is Cookies for Cops as a thank you because domestic violence situations can be very dangerous for all involved. The Board and County Attorney thanked DVIP for all their assistance to help Domestic Violence victims.

PROCLAMATION DOMESTIC VIOLENCE AWARENESS MONTH OCTOBER 2017

WHEREAS, domestic violence, dating violence and stalking affects women, children and men of all racial, cultural and economic backgrounds, causing long-term physical, psychological and emotional harm; and

WHEREAS, one in three Americans has witnessed an incident of domestic violence; and

WHEREAS, children who experience domestic violence are at a higher risk for failure in school, mental illness, substance abuse, suicide, and may choose violence as a way to solve problems later in life; and

WHEREAS, domestic violence in rural communities exists as a hidden, silent and often unrecognized crime that is often underreported; and

WHEREAS, through the inspiration, courage and persistence of victims of domestic violence, their children and advocates, our communities are learning to recognize the impact of violence in the home and intimate relationships; and

WHEREAS, the Domestic Violence Intervention Program has worked to end violence in intimate relationships for more than 38 years through the collaborative partnerships of advocates, volunteers, local municipalities, criminal justice, health and human services, faith communities, business leaders and private citizens; and

WHEREAS, our community's achievements should be commended and we must continue our commitment to respect and support victims of domestic violence and to prevent future violence in our community.

NOW, THEREFORE, be it resolved that we, the Supervisors of Des Moines County, do hereby proclaim the month of October 2017 to be: **DOMESTIC VIOLENCE AWARENESS MONTH** in Des Moines County, and urge all citizens to work together to eliminate domestic violence, dating violence and stalking from our community.

Broeker motioned to open the public hearing for the 2018 Budget Amendment. Cary seconded. The County Auditor stated the amendment was to increase the Conservation Board budget by \$605,000. All funds are coming out of Conservations Reserve Fund to cover \$550,000 in costs for Big Hollow Improvements. \$25,000 for Leopold Rec Area, which part is covered by the Fish Habitat Grant. \$30,000 for Starr's Cave Nature Center, which part is covered by the Murray Foundation Grant. No public comment was received. Cary motioned to close the public hearing. Broeker seconded. Broeker motioned to approve the budget amendment. Cary seconded.

Jeff Hanan, Land Use Administrator presented the resolution and final plat for Goat Farm Subdivision. This is a three-lot minor subdivision containing 12.98 acres and located in Benton Twp. The Owner and Subdivider is Jon and Cindy Fye, 10165 Sperry Road, Sperry. The only stipulation is Lot 3 will be attached to parcel 07-07-400-011. He recommended approval. Broeker motioned to approve. Cary seconded.

RESOLUTION

WHEREAS Section 354.8 of the Code of Iowa states that a governing body shall certify by resolution the approval of a subdivision plat, and,

WHEREAS the Final Plat for **Goat Farm Subdivision** has been reviewed for conformance to applicable County standards by the Des Moines County Health Department, Secondary Roads Department, County Auditor, Zoning Commission Chair and Land Use Department and has been duly recommended by the aforementioned entities for approval,

NOW THEREFORE, BE IT RESOLVED: That the Board of Supervisors hereby approves the Final Plat of **Goat Farm Subdivision** with the following condition:

• That Lot 3 be attached to adjoining parcel number 07-07-400-011
