WHEREAS the Final Plat for **Second Addition to Olomon Subdivision** has been reviewed for conformance to applicable County standards by the Des Moines County Auditor, Health Department, Secondary Roads Department, and Land Use Department and has been duly recommended by the aforementioned entities for approval,


NOW THEREFORE, BE IT RESOLVED: That the Board of Supervisors hereby approves the Final Plat of **Second Addition to Olomon Subdivision**, with the following conditions:

- If any portion of the new septic system for Lot 4 will encroach onto adjoining propert(ies), the
 owner shall dedicate an easement extending at least 10 feet around the perimeter of that
 system, for any portion that so encroaches, and said easement shall be recorded prior to the
 occupancy of any dwelling on Lot 4.
- The following provisions of the Des Moines County Subdivision Ordinance shall be waived:
 - Article VI, Section G(1), along with Article VI, Section D(4)(a), to allow for an access easement of less than 33 feet in width.
 - o Article VI, Section E(5), to allow for a shared driveway of less than 22 feet in width.
 - o Article VI, Section D(4)(c), to allow for a roadway without a turn-off for vehicles to pass.
