October 21, 2025

The Des Moines County Board of Supervisors met in a regular session at the Court House in Burlington at 9:00 AM on Tuesday, October 21, 2025, with Chair Jim Cary, Member Tom Broeker, and Vice-Chair Shane McCampbell present. This meeting was also held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meeting with Department Heads: County Auditor Sara Doty stated her office remains busy working on the City/School Election. Absentee voting is available in the office from 8:00 am – 4:30 pm until November 3rd at 4:30 pm. On November 4th you will vote at your precinct. County Attorney Lisa Schaefer stated she attended a job expo on Thursday last week. Met a lot of potentially good interns. Her office remains busy. IT Director Brandon Mehmert reported his office is busy. Sheriff Kevin Glendening reported the jail population is at 85. Emergency Management Director Shannon Prado stated the hazard mitigation plan is still in the works. Maintenance Director Rodney Bliesener stated the job posting for a Lead Maintenance position is still available. You can find an application on our county website. Public Health Director Christa Poggemiller stated there will be an additional flu clinic this week on the 23rd from 10:00 am – 2:00 pm. Walk ins are welcome. Assistant Land Use Administrator Jarred Lassiter reported he has received a few new inquiries on subdivisions. County Recorder Natalie Steffener stated passports and real estate recordings are on the rise currently. Her office remains working on back indexing. Assistant County Attorney Trent Henkelvig is in attendance. Safety Director Angela Vaughan was present. County Engineer Brian Carter reported Northfield Rd. in Mediapolis will be closing this morning and will be closed for a couple of days to work on a culvert. 260th Rd., the far north gravel road off of Highway 61 is now open.

Approval of Accounts Payable Claims in the amount of \$1,307,537.40 was presented. Broeker made a motion to approve and was seconded by McCampbell.

Approval of a Letter of Support for Great River Housing Trust Fund was presented. Broeker made a motion to approve and was seconded by McCampbell.

Approval of Resolution #2025-054 and Final Plat for Hillside Acres Subdivision was presented. Assistant Land Use Administrator Jarred Lassiter spoke on this and recommended approval. McCampbell made a motion to approve and as seconded by Broeker.

WHEREAS Section 354.8 of the Code of Iowa states that a governing body shall certify by resolution the approval of a subdivision plat, and,

WHEREAS the Final Plat for **Hillside Acres Subdivision** has been reviewed for conformance to applicable County standards by the Des Moines County Auditor, Health Department, Secondary Roads Department, and Land Use Department and has been duly recommended by the aforementioned entities for approval,

NOW THEREFORE, BE IT RESOLVED: That the Board of Supervisors hereby approves the Final Plat of **Hillside Acres Subdivision**, with the following condition:

• A permit for an Onsite Waste Water Treatment System shall be obtained from the Des Moines County Health Department prior to construction of any new residence, and a code compliant system shall be installed prior to its habitation.

During public input, Charles Tonkinson, Yarmouth, asked if the public would be able to speak at the work session. Cary stated there will be no public input. He informed the board of the bat population and the danger of the bats and wind turbines. Allison Mohr, Yarmouth, also spoke regarding the wind turbines. She asked Public Health Director, Christa Poggemiller if the Board of Health would be bringing any recommendations to the Board of Supervisors regarding wind turbines.

The meeting was adjourned at 9:29 A.M.

Following the meeting a work session was held regarding Wildlife Monitoring and Mitigation of the Wind/Solar Ordinance.
