The Des Moines County Board of Supervisors met in a regular session at the Court House in Burlington at 9:00 AM on Wednesday, November 18, 2025, with Chair Jim Cary, Vice-Chair Shane McCampbell, and Member Tom Broeker present. This meeting was also held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meeting with Department Heads: County Auditor Sara Doty reported she will be in Des Moines for a conference for the rest of the week. Her office remains busy. IT Director Brandon Mehmert reported his office is busy. Sheriff Kevin Glendening stated the jail population is at 95. Emergency Management Director Shannon Prado reported she is busy. Assistant Land Use Administrative Assistant Jarred Lassiter reported his office is busy. Conservation Director Chris Lee reported they put memorial rock up yesterday at Big Hollow. They have new events on the calendar. To find out when they are, check out their Conservation Facebook page. County Recorder Natalie Steffener reported her office is busy. Maintenance Director Rodney Bliesener introduced his new hire, Zakary Reynolds. He reported his office is busy. Safety Director Angela Vaughan was present. County Engineer Brian Carter would like to recognize Scott Salisbury. He has been with the County for 19 years and is retiring. Carter would like to thank him for his service. Carter also gave an update on projects.

Approval of Accounts Payable Claims in the amount of \$297,338.45 were presented. McCampbell made a motion to approve and was seconded by Broeker.

Approval of Personnel Actions was presented. Maintenance – Zakary Reynolds, Lead Maintenance, \$34,934.41 yearly effective 11/17. Broeker made a motion to approve and was seconded by McCampbell. Correctional Center – Bryce Wade, FT Correctional Officer, 12-month step increase, \$52,662.04 yearly starting on 12/19. McCampbell made a motion to approve and was seconded by Broeker.

Broeker motioned to approve November 12th, 2025, regular meeting minutes and was seconded by McCampbell.

Approval of the 2nd Tier Canvass Results for the City/School Election Held on November 4th, 2025, were presented. Broeker made a motion to approve and was seconded by McCampbell.


During public input, Terry Davis stated the County Engineers Office has been very easy to work with. He would like to thank Brian and his crew for making him and all the surrounding property owners aware of projects going on and answering all questions they have. Davis is also on the Conservation Board and informed the Board that they submitted another letter on recommendations for setbacks. Charles Tonkinson, Yarmouth, also gave comments on the wind turbines. Ron Helling, Conservation Board, would like to echo what Davis said regarding the recommendations they gave. Rose Fischer, New London, also spoke on the wind turbines.

The meeting was adjourned at 9:46 A.M.
