    - Salary was incorrect by a dollar. It should be \$80,204.
    - IPERS proposed number was incorrect and needs to be updated to \$7,651.

- Due to increasing healthcare costs, the health insurance needs to be increased by 5% which would bring it to a total of \$22,619.

  - c. Shanna also asked to increase her vacation time to match her employees to 149 hours.
  - d. Chair Broeker would like to see corrected numbers on FICA and IPERS.
  - e. DESCOM Director Krogmeier requested funding to replace one console desk for the next fiscal year. Discussion was underway and the only comment came from Chair Broeker to move it from the miscellaneous line item and put it in an office equipment line item. He requested that she speak with Budget Director Cheryl McVey.
