The Des Moines County Board of Supervisors met in a regular session at the Court House in Burlington at 9:00 AM on Tuesday, April 21st, 2026, with Chair Shane McCampbell, Vice Chair Tom Broeker and Member Jim Cary present. The meeting was also held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meeting with Department Heads: Safety Director Angela Vaughan reported she is busy. Conservation Director Chris Lee stated field trips are beginning at Starrs Cave. Maintenance Director Rodney Bliesener reported the Sheriff's Department parking lot is moving along. A Lead Maintenance job opening will be posted today. Sheriff Kevin Glendening reported we will be holding an active threat drill at the Court House today. The Court House will close at 3:00 P.M. Emergency Management Director Shannon Prado is working with Mediapolis regarding the weather sirens. Our jail population is 93. IT Director Brandon Mehmert stated his office is busy. County Recorder Natalie Steffener reported her office is busy. Veterans Affairs Administrator Brooke Marland stated 27 Veterans attended the April 8th Coffee and Conversation. Assistant County Attorney Trent Henkelvig was in attendance for an agenda item. County Auditor Sara Doty stated she is currently working on programing election equipment for the upcoming Primary Election. Assistant Land Use Administrator Jarred Lassiter reported he remains busy. County Engineer Brian Carter reported he was out of the office last week for a conference in Texas. We are on the schedule to start County dust control next week. Sheriff's Parking Lot project is moving along. With the Mississippi River being high, Sullivan Slough is closed due to flooding.

WHEREAS, Article II, Section A of the revised Ordinance No. 25 states that the regulations shall apply to, "all lands and development which have significant flood hazards", within a set of specified Flood Insurance Rate Maps (FIRMs) for Des Moines County, including, among others, "Panels 19057C0305G, 19057C0306G, 19057C0307G, 19057C0308G, 19057C0309G, 19057C0326G, 19057C0328G, dated May 26, 2026".

NOW THEREFORE, BE IT RESOLVED: That following the approval of the revised Ordinance No. 25 by the Board of Supervisors, said Ordinance shall take effect on May 26, 2026, in place of the previous version of the Ordinance adopted on October 5, 2021.

RESOLUTION #2026-027

APPROPRIATE FUNDS TO OPERATE COUNTY OFFICES AND DEPARTMENTS FOR FISCAL YEAR 2027

WHEREAS, in accordance with Section 331.434(6) of the Code of Iowa, the Board of Supervisors of Des Moines County, Iowa, is required to appropriate funds to operate all offices and departments of said county for Fiscal Year 2027.

THEREFORE BE IT RESOLVED, that the Board of Supervisors do hereby authorize the appropriations for Fiscal year 2027 as follows:

SECTION 1: The amounts itemized by department on the following Schedule A are hereby appropriated from resources of each fund so itemized.

SECTION 2: Subject to the provisions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective July 1, 2026.

SECTION 3: In accordance with Section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditure of money for any purpose in excess of the amount appropriated pursuant to this resolution.

SECTION 4: If at any time during the budget year the Auditor shall ascertain that the available resources of a fund for that year will be less than said funds total appropriations, she shall immediately so inform the Board and recommend appropriate corrective action.

SECTION 5: The Auditor shall establish separate accounts for the appropriations authorized in Section 1, each of which account shall indicate on a report the status of such accounts to the applicable department monthly during the budget year.

SECTION 6: All appropriations authorized pursuant to this resolution lapse at the close of business June 30, 2027.
